



# FROM SUSTAINABLE BUILDINGS AND INFRASTRUCTURE TO SUSTAINABLE CITIES AND COMMUNITIES

## URBAN SUSTAINABILITY MANAGEMENT

The sustainability performance of buildings and infrastructure is linked not only to their intrinsic performance but also to the performance of their immediate surroundings.

Specifying the requirements for the sustainability performance of buildings or infrastructure is a necessary but not a sufficient condition for improving the sustainability of cities and communities. A more holistic approach is needed.

This is why standardisation bodies from some 50 countries joined forces with ISO to develop a common language and methodology for implementing urban sustainability management. An immediate outcome was the ISO 37101 standard published in July 2016.

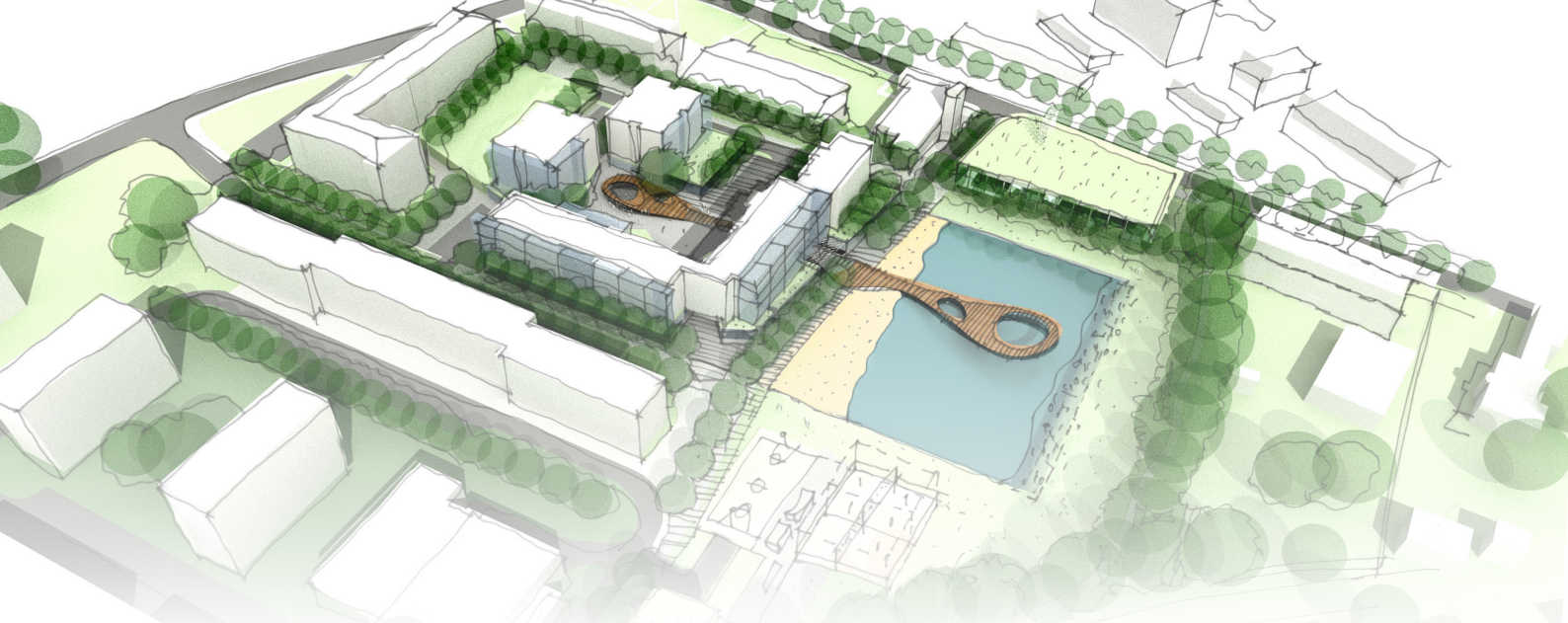
### What is the ISO 37101 standard?

- **A globally recognised common framework and language for all types of interested parties and urban projects that is based on:**
  - the 6 fundamental purposes of sustainability;
  - the 12 principle areas for community action covering the governance, environmental, economic and social dimensions of sustainability.
- **An holistic approach to integrate buildings, infrastructure and urban projects:**
  - to optimise the sustainability performance of cities and communities;
  - to support essential management processes (context, strategy, action plan, performance measurement).
- **An open and flexible system that does not impose:**
  - a specific vision for a sustainable city;
  - a specific set of objectives and indicators.

### Global benefits for ISO 37101 users and their partners

- **A common language** that helps clarify and enhance stakeholder co-operation and exchange.
- **A structured methodology** to monitor the overall performance of buildings and infrastructure and their surroundings **using relevant indicators**.
- **Recognition** via either formal certification or a claim of conformity with the standard, depending upon the circumstances.
